

## **Mitsubishi Motors Customer Survey Competition Prize Draw October 2021**

### **TERMS & CONDITIONS**

1. This competition is conducted by Mitsubishi Motors Australia Ltd ABN 53 007 870 395 (the "Promoter"). Information on how to enter forms part of the conditions of entry. Entry into the competition or acceptance of a prize constitutes acceptance of these terms and conditions as amended from time to time.
2. Total prize pool is \$1,500. 1<sup>st</sup> prize: \$750 Mitsubishi voucher, 2<sup>nd</sup> prize: \$500 Mitsubishi voucher, 3<sup>rd</sup> prize: \$250 Mitsubishi voucher. The vouchers must be used at authorised Mitsubishi dealerships and can be redeemed for vehicle servicing, purchase of genuine parts and accessories or towards a new Mitsubishi vehicle. The prizes are not transferrable and not redeemable for cash.
3. Only respondents invited by Nidasu Pty Ltd (the Promoter's Agent) are eligible to participate in the online survey. To be eligible for this prize draw, all respondents must complete the survey within 30 days of the date of their initial invitation, and survey responses must be lodged between 1 July 2021, and 11.59pm Adelaide time on 30 September 2021.

The winners will be notified by telephone using the contact information provided when responding to the survey no later than two working days after the draw and the winners' names will be published at [mitsubishi-motors.com.au/survey-competition](http://mitsubishi-motors.com.au/survey-competition) within 10 working days of the draw and remain on the page for not less than 28 days.

11. The winners will be selected at random using electronic software via 'randomdraws.com.au' from all surveys completed online within the specified time periods. Prizes will be drawn in order of prize value, beginning with the highest value prizes.

12. In the event of a prize not being claimed, an unclaimed prize draw will be held on 29 October 2021 at Mitsubishi Motors Australia Ltd, 1 Sir Richard Williams Avenue, Adelaide Airport, SA at 2pm. The unclaimed prize draw will be conducted in the same manner as the prize draw described in clause 11 above.
